The October Reunion was attended by 58 members, who had braved the train guards' strike, the Olympic medal winners' parade and plain old age to get to Marble Arch. This included 22 members, who had come from Peterborough and other Northern parts.

This is a light-hearted gathering, but we paused at the start to remember Norman Robinson, Mary Isaacs and Keith Tribe, who had died since the AGM in May. Norman, aged 90, had a permanent smile and was a stalwart of the Op and Dram Society. Mary, 93, was a popular member of the Life Company and had worked mainly in OB Service/OB3; her father had worked at the Pearl before and after the First World War. Keith, only 72, was a well-liked Pearl personality, who had worked in various parts of the General Branch, finishing up as a Manager at Hallmark in the City, before it was closed by the new owners when the Pearl flag was finally lowered.

Many were amazed that it was a whole year since 270 were gathered at 252 High Holborn. Therefore, one point of conversation was the Chairman's comment that although membership had risen over the past two years, attendances at these twice-yearly gatherings had fallen gradually. He conjectured that this situation might improve if we met on a Saturday so that those younger oldies who were still at work could come along. The Secretary would welcome any written thoughts that members may have about this, and it will be discussed again at the 2017 AGM on 9 May. The closure of Holborn, followed quickly by the disappearance of the Pearl Assurance, does mean that our catchment area for new members will slowly dry up, but everyone present felt that PCOPA should continue to function, even if the dates or frequency of meetings were to change.

A quiz on London trivia led by Pam Holland followed plus the excitement of a prize raffle before retired Pearl folk tucked into the buffet and caught up on all the gossip.

Peterborough Club news

The summer has once again seen the club active in its outings with a greater emphasis on residential trips. Two trips were made with one going to the Golden Lion Hotel in Shrewsbury and the other, more recent one, to the Second World War sites of Normandy.

There were also visits to the Rugby Football Union headquarters at Twickenham and the Secret Bunkers of Kelvedon Hatch although amusingly, the secrecy was limited to its name with many road signs and posters directing visitors to its exact location! The secret bunkers were supplemented with a visit to the RHS gardens at Hyde Hall, which were well worth the time. 

Beware of pension scams

People have lost their life savings after falling for a pension scam. Don't let it happen to you.

We urge members to continue to be vigilant about pension scams. The new pension freedoms have brought with them increased opportunities for scammers, who may try to lure you with promises of upfront cash and one-off deals with guaranteed high returns. Please be very careful of any such promises as risk-free, guaranteed investment returns are highly unlikely.

Please also be wary of unsolicited texts, emails and cold calls, as scammers may claim to be from Pension Wise or other government-backed organisations – these organisations would NEVER call you to offer a pension review.

Tax help for older people

Tax Help for Older People is a service from the charity Tax Volunteers, which provides free, independent and expert help for older people on lower incomes, who cannot afford to pay for professional tax advice. With over 420 volunteers and a national call centre, it doesn't matter where you live.

Marriage tax allowance

The marriage tax allowance entitles couples to a useful tax break worth up to £432 for new claimants. However, the government estimates that some 3.6 million of the 4.2 million eligible couples have not taken advantage of the offer.

The allowance enables couples to transfer 10% of their personal tax allowance (£1,100 in 2016/17) between them, effectively making it tax free. The scheme started on 6 April 2015 and it is possible to backdate claims to this date, which means that couples can claim £212 for 2015/16 and £220 for 2016/17 – a total of £432.

To qualify, couples must meet the following criteria:

- Be married or in a civil partnership
- Both parties must be born on or after 6 April 1935
- One party must be a non-taxpayer (i.e. earns up to £11,000 in 2016/17 and up to £10,600 in 2015/16)
- The other party must be a basic rate (20%) taxpayer (i.e. up to £43,000 in 2016/17 and up to £42,385 in 2015/16)

Once set up, the arrangement will remain in place, and couples signed up for the scheme should review their situation every year to ensure they still qualify.

Topping up your State Pension

Uptake of the government's State Pension top-up scheme remains low following its launch in October last year. This is possibly due to lack of awareness or because its announcement has been overshadowed by other pension reforms dominating the media.

The State Pension top-up scheme runs until 5 April 2017 and is available to those who are entitled to a UK State Pension and reached State Pension Age before 6 April 2016. The scheme invites eligible pensioners to pay a one-off lump sum in return for an increase in their pension of between £1 and £25 per week.

For example, an extra £1 of pension a week (£52 a year) for life will cost a 65-year-old £890, while an extra £5 a week (£260 a year) will cost £4,450. To get the maximum additional £25 a week (£1,300 a year) someone aged 65 would need to pay £22,250.

For a 75-year-old wanting an extra £1, £5 or £25 a week, the lump sum required would be a lower £674, £3,370 and £16,850 respectively.

The income is index linked and, in most cases, some or all of the extra pension can be passed on to your spouse or civil partner after you die.

Are you claiming the Winter Fuel Payment?

The Winter Fuel Payment is available to people born on or before 5 May 1953. How much you can get depends on your circumstances during the qualifying week, which for winter 2016/17 is 19–25 September 2016. For example, if you live alone and qualify, you will get £200, and if you are aged over 80 in the qualifying week, you will get £300.

You can still claim Winter Fuel Payment if you receive a State Pension and you live in Switzerland or an EEA country (except for Cyprus, France, Gibraltar, Greece, Malta, Portugal or Spain).

To claim, call the Winter Fuel Payment Centre on 03459 15 15 15. You will need:

- your National Insurance number
- your bank details
- your BIC and IBAN numbers if you live in the EEA or Switzerland
- the date you were married or entered into a civil partnership You only need to claim once as the payment will be made automatically the following year.

Smart energy meters for everyone

As part of the government's plan to reduce carbon emissions, smart meters for gas and electricity will be offered to every home in the country between now and 2020. Smart meters make it easier for householders to save energy.

The smart meter is installed in place of your existing meter and means that you will no longer need to send meter readings to your gas or electricity supplier. Instead, this is handled by the smart meter automatically. This means estimated bills will be a thing of the past and you will be charged only for the gas or electricity you use.

You don't have to upgrade to a smart meter but if you do, your energy supplier will install it free of charge and by appointment (beware of anyone offering to install a meter and charge you for it). You will also receive a portable 'smart energy monitor', which gives a real-time reading of your energy use and what it is costing you.
